### TRAP RENTAL AGREEMENT

I, \_\_\_\_\_, AM ACCEPTING RESPONSIBILITY FOR THE TRAP, OR CARRY CAGE, PROVIDED TO ME BY PUTNAM COUNTY ANIMAL CONTROL. I AGREE TO PAY A \$50 DOLLAR DEPOSIT FOR THE RENTAL OF THE TRAP OR CAGE. A RENTAL FEE OF EITHER \$5 OR \$10, DEPENDING ON THE SIZE OF THE TRAP, WILL BE DEDUCTED FROM THE DEPOSIT EACH WEEK. IF I RETURN THE TRAP WHILE THERE IS STILL A REMAINDER LEFT ON THE DEPOSIT, THAT AMOUNT WILL BE REFUNDED TO ME. IF I CHOOSE TO KEEP THE TRAP LONGER THAN THE DEPOSIT ALLOWS, I UNDERSTAND THAT I WILL NEED TO MAKE ANOTHER DEPOSIT TO RETAIN CUSTODY OF THE TRAP.

DOG TRAP (60"x20"x26"): \$10/ WEEK

CAT TRAP (32"x10"x12"): \$5/ WEEK

I UNDERSTAND THAT SHOULD THE TRAP OR CAGE BE LOST, DAMAGED, OR STOLEN ONCE PLACED INTO MY CUSTODY, I WILL BE RESPONSIBLE FOR THE FULL REPLACEMENT VALUE OF THE ITEM, *PER ITEM*, AS FOLLOWS:

DOG TRAP (60"x20"x26"): **\$335**

CAT TRAP (32"x10"x12"): **\$75**

I AGREE TO ACTIVATE THE TRAP PROVIDED BY PUTNAM COUNTY ANIMAL CONTROL FOLLOWING THE APPROVED SCHEDULE WHICH I RECEIVED AT THE TIME OF THIS AGREEMENT. I FURTHER AGREE TO PROVIDE FOOD AND WATER TO ANY ANIMAL CONFINED BY THE TRAP UNTIL PUTNAM COUNTY ANIMAL CONTROL CAN ARRIVE TO TAKE CUSTODY OF THE ANIMAL.

IF I AM AWAY FROM MY RESIDENCE FOR A PERIOD GREATER THAN 24 HOURS, I WILL INFORM PUTNAM COUNTY ANIMAL CONTROL, PRIOR TO LEAVING, SO THEY MAY RECOVER THE TRAP FROM MY PROPERTY TO PREVENT THEFT OF THE ITEM WHILE I AM AWAY.

REPRESENTATIVES OF PUTNAM COUNTY ANIMAL CONTROL HAVE MY PERMISSION TO ACCESS MY PROPERTY FOR THE PURPOSES OF SERVICING, INSPECTING, OR RECOVERING ANY TRAP IN MY CUSTODY, DURING PRESCRIBED BUSINESS HOURS.

IF I HAVE ANY QUESTIONS, OR NEED ASSISTANCE WITH THE TRAP, I UNDERSTAND THAT I CAN CALL THE PUTNAM COUNTY ANIMAL CONTROL MAIN SHELTER AT (386) 329-0396.

## **TRAP USAGE AND RETRIEVAL INFORMATION**

PUTNAM COUNTY ANIMAL CONTROL LIMITS THE USE OF TRAPS TO PARTICULAR TIME FRAMES FOR THE HEALTH AND SAFETY OF THE TRAPPER AND ANIMAL. ***TRAPS ARE ONLY TO BE USED FROM SUNDAY THRU THURSDAY.*** THIS LIMITS THE AMOUNT OF TIME THE ANIMAL SPENDS IN THE TRAP BEFORE PUTNAM COUNTY ANIMAL CONTROL CAN TAKE CUSTODY OF IT. PLEASE NOTE THAT THE TRAP USER IS RESPONSIBLE FOR FEEDING AND WATERING THE ANIMAL WHILE IT IS CONFINED.

***IF YOU HAVE ALREADY USED THE TRAP AND ARE READY FOR PUTNAM COUNTY ANIMAL CONTROL TO COLLECT THE ANIMAL, YOU MUST CALL THE MAIN SHELTER AT (386) 329-0396 PRIOR TO 9 AM.*** THE ANIMAL CONTROL OFFICERS RECEIVE MANY CALLS DURING THE DAY AND WANT TO MAKE SURE THAT THEY ARE ABLE TO COME RETRIEVE THE TRAPPED ANIMAL IN A TIMELY FASHION.

IF YOU WILL BE AWAY FROM YOUR HOME FOR A PERIOD OF TIME LONGER THAN 24, YOU MUST CALL PUTNAM COUNTY ANIMAL CONTROL TO RETRIEVE YOUR TRAP, PRIOR TO YOUR DEPARTURE. THE TRAP WILL BE RETRIEVED FROM THE PROPERTY TO PREVENT THE LOSS OF THE TRAP AND TO HELP KEEP THE TRAP RENTER FROM HAVING TO UNNECESSARY PAY REPLACEMENT COSTS.

PLEASE REMEMBER THAT YOUR SIGNATURE ON THE TRAP RENTAL AGREEMENT PROVIDES PUTNAM COUNTY ANIMAL CONTROL WITH ACCESS TO YOUR PROPERTY FOR THE PURPOSES OF SERVICING, INSPECTING, OR RECOVERING ANY TRAP IN MY CUSTODY, DURING PRESCRIBED BUSINESS HOURS. PRESCRIBED BUSINESS HOURS WILL BE DEFINED AS MONDAY THRU FRIDAY FROM 8:00 IN THE MORNING UNTIL 4:30 IN THE AFTERNOON.
