These roads will remain closed until Tuesday of next week due to the upcoming rains and Tropical Storm 16.

For citizens wishing to haul their own vegetative storm debris without tipping fees, a dropoff site is open. The schedule is Monday through Saturday from 8:30am until 5pm. The location

is at the Fairgrounds overflow parking at 118 Fairgrounds Rd. East Palatka. Residents using this site will need to show proof of residency for Putnam county. An ID, utility bill or tax bill linking their name to the property is sufficient. No commercial vehicles or other types of debris will be accepted at this site. Residents and commercial vehicles can take vegetation and other types of debris to the Central Landfill, Interlachen convenient center or the Huntington convenient center. Tipping fees may apply depending on size and type of debris. Please contact the sanitation department at 386-329-0395 if you have questions. (NO BAGGED DEBRIS CAN)

What are the current hours for Putnam County Emergency Management? Putnam County Emergency Management is currently at Level 2 staffing and has the hours of 08:30 am – 5pm.

What is the number for the Putnam County Recorded Information Line? What information can be heard on this line? The number is 386-326-7132 and you can hear a recorded message of our latest Situation Report and other important information.

When I start the cleanup process, where should I put the debris? Place the debris near the road on "county right-of-way" at least five feet from any obstructions such as fences or water meter boxes. Piles of debris need to be separated between vegetation and construction material.

If the debris is mixed it doesn't meet the criteria for pick up by contractor. Call Putnam County Sanitation Department 386-329-0395 with questions. (See form below)

Who do I call if I'm unsure if a road is a private road or county right-of-way to put my debris out for pick up? Call the Putnam County PUBLIC WORKS Department at 386-329-0346—for address / road questions related to county right-of-way.

I have mosquitos! Who do I call to advise I have a mosquito problem? You can call Putnam County Sanitation Department 386-329-0395 and let them know where there is an increase in mosquitos

I heard you can apply for FEMA assistance. Is this true and have we received a Major Disaster Declaration? Yes, we received official word that Putnam County has received "Major Disaster Declaration". It is very important for you to report damage to your insurance company, take lots of pictures, save receipts and document all actions and correspondence related to applications and repairs to your property. If you have damage or loss from this disaster, you can complete a FEMA application online now and apply for Individual Assistance. To fill out the application visit www.disasterassistance.gov. You can also apply over the phone at 800-621-3362.

Will FEMA replace my food that I lost during the storm? No, FEMA does not replace food that was lost during the storm however there are several resources available in our community. You can find a list of these numbers in the community resources section of this report.

Should I leave my wet carpet and / or my ruined belongings so a FEMA inspector can assess damage? Inspectors are able to assess damages even after the applicants have cleaned up. Keeping wet, molded or ruined material around the home may be a health issue.

Does FEMA need me to take photos of my damaged stuff before disposing of it? Photos are not necessary for a FEMA inspection. The real property damages to the home will substantiate any damages to discarded personal property. Taking photos for insurance purposes would be up to your discretion and expense.

What numbers do I call to get information on my SNAP, EBT or other government assistance programs? A number to call if you have not received your benefit or would like to request additional assistance from the SNAP program is 1-866-762-2237.

What are the dangers of drinking well water that may have been contaminated?

Waterborne illnesses are caused by microbes or parasites in untreated or contaminated water. All homes that have a private well that was under water from the flooding or lost its prime from being without power needs to be sanitized. Signs and symptoms include nausea, vomiting, diarrhea, stomach cramps and fever. If you have any of these symptoms seek medical attention. YOU OR YOUR FAMILY CAN GET VERY SICK IF YOU DRINK CONTAMINATED WATER. Visit the website http://putnam.floridahealth.gov/ Click on "after the storm information" that is found at the top.

There are tree stumps and debris in the river and creek. What is being done to clear the waterways? Please use caution while debris is being located. Some of this debris could cause serious damage to property or loss of life if hit at a high rate of speed. There are state and federal agencies working on the debris issue.

IMPORTANT FEMA INFORMATION


There are three things that can halt FEMA disaster assistance in the very beginning. If someone tells you it has been 10 days or longer since they registered and they haven't heard anything it is probably because of one of these three things.

- **-They said they have insurance when they applied:** *If they said they had insurance when they registered, their claim will not go forward until they provide FEMA with a denial or lack of sufficient insurance. They can find out how to submit the information by calling the HELPLINE at 1-800-621-3362.*
- -They received an SBA application: When applicants apply, based on income/number in the family, it is determined if there is a possibility that they may be able to repay a loan. If the answer is yes, they are sent information on how to apply for a loan from the SBA. If they receive the SBA application THEY MUST return it before they may be referred back to FEMA for possible assistance. The reason is that applicants are expected to take advantage of all available resources, and SBA is considered a major resource. When the application is returned it is evaluated as any other loans are, based on assets/liabilities and ability to repay, so the applicant's may or may not be approved for the loan. This does not apply to housing assistance, since SBA does not provide for that, but does apply for all personal property. The claim for personal property will stop until the SBA application is received. Yes, SBA gives loans to individuals in time of disaster.
- **-The FEMA inspector cannot reach them:** *Typically FEMA inspectors will attempt to contact an applicant three times, if they cannot reach them, the applicant does not return calls, or misses appointments, the inspector will move on until the applicant initiates contact-they do that by calling the HELPLINE 800-621-3362.*

Use the Funds for the intended use-Applicants may receive the funds BEFORE they receive the letter telling them what the funds are for. It is critical that they wait for the letter. If they use the funds for things other than what it is intended for they will not be eligible for possible additional assistance. For example, if an applicant receives rental assistance and they use it to buy other things they will not be able to receive additional rental assistance. If they use rental funds appropriately and meet a couple of other requirements they may continue to receive assistance—possibly up to 18 months, if needed.

"MOST of the time when applicants say "FEMA won't help me" it is because they have not read or understood the letter they were sent. They read the first few sentences which may say they have been denied, then stop. Usually the letter tells them why and often it is just that more information is required, such as identity or damage verification or they need to submit insurance denial, or something like that. If they need help understanding the letter, they should call the HELPLINE.

All debris types must be separated. Vegetation such as tree branches, appliances, construction materials, and household garbage must be piled separate of each other. The piles need to be 10 feet away from fire hydrants, fences and utility boxes above and below grade. All debris must be placed on the edge of the County right-of-way to be picked up. Please remember that Putnam County staff, nor their contractors, can remove downed trees or other debris from private property, including private roads. If debris is on a private road or private property, please move to the county right of way for pick up. If you are not able to do this yourself, you should contact a licensed tree removal service. Debris Contractors are not allowed to pick up from private property. You can call Public Works at 386-329-0346 to confirm if your road is private or is county right-of-way. Please do not place the listed hazardous waste curbside but rather take it to the sites listed below.

If you choose to take your debris to the central landfill, the Huntington or Interlachen convenient center, you may experience delays. Tipping fees are not waived. However, at the central landfill, residents may bring vegetative debris less than 4" in diameter and less than 6' in length without this going against the weight allowed per year, per household which is 4,000 lbs. Residents can take their own vegetative debris to the collection site at 118 Fairgrounds Rd. in E. Palatka. No bagged debris can be taken at this site.
